

LaGrange Township Regular Meeting  
November 17, 2025

Supervisor Brittany File called the meeting of the LaGrange Township Board to order at 7:00pm. Pledge of allegiance was given in unison. Roll call found Supervisor Brittany File, Treasurer Naomi J. Criswell, Trustee Amy Juroff, and Clerk Tasha E. McCoy present, and Trustee Paul File absent.

Public comment was opened at 7:01pm. Diamond Lake Weed District Representative greeted the Board on an upcoming meeting (December 4<sup>th</sup>) to discuss Vendor options for the lake treatment in 2026. Public comment closed at 7:02pm.

Supervisor Brittany File made a motion, seconded by Trustee Amy Juroff, to approve the minutes of the October 20, 2025 meeting as presented. Motion carried, 7:02pm.

Treasurer Naomi Criswell provided the Treasurer's Report. Clerk McCoy made a motion, seconded by Trustee Amy Juroff, to approve Settlements #5 of the Summer 2025 Taxes. Motion carried, 7:03pm.

Communications were read to the Board by Supervisor Brittany File.

Trustee Amy Juroff made a motion, seconded by Supervisor Brittany File, to approve the Current Month Warrant Report, totaling \$65,961.23. Motion carried, 7:06pm.

Clerk McCoy made a motion, seconded by Treasurer Naomi Criswell, to table Indiana Michigan Power Light at intersection of Park St. & Maple St. to the December 2025 meeting. Motion carried, 7:06pm.

The Central Cass Interlocal Fire Department (CCIFD) Fire Chief updated the Board on fire truck maintenances, conditions of fire trucks, financials of the CCIFD, and estimates of a new fire truck in the future. CCIFD Fire Chief Locke reported 19 runs in October.

Trustee Juroff updated the Board on the Central Cass Ambulance Authority (CCAA) and Southwestern Michigan Community Ambulance Service Inc. (SMCAS) are working on a formal contract for use of the Ambulance building.

The Zoning Administrator presented to the Board.
