PLEASE TAKE NOTICE that any qualified elector of Jefferson, Calvin, LaGrange, and Penn Townships who is not already registered, may register to vote at the office of the Township Clerk; the office of the County Clerk; a Secretary of State branch office; or other designated state agency. Registration forms can be obtained at mi.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Tuesday, July 23, 2024**.
