Supervisor Brittany File called the meeting of the LaGrange Township Board to order at 7:00pm. Pledge of allegiance was given in unison. Roll call found Supervisor Brittany File, Trustee Amy Juroff, Trustee Paul File, Treasurer Naomi J. Criswell and Clerk Tasha E. McCoy present.

Public comment was opened at 7:01pm. Public comment closed at 7:06pm.

Supervisor Brittany File made a motion, seconded by Trustee Paul File, to approve the minutes of the July 20, 2026 meeting as presented. Motion carried, 7:07pm.

The Treasurer's Report was provided to the Board. Trustee Amy Juroff made a motion, seconded by Trustee Paul File, to approve Tax Settlement #1 of Summer 2026 Taxes, motion carried at 7:07pm.

Communications were read to the Board and Public by Supervisor Brittany File.

Trustee Paul File made a motion, seconded by Trustee Amy Juroff, to approve the Current Month Warrant Report, totaling \$65,491.08 Motion carried, 7:09pm.

Treasurer Naomi J. Criswell made a motion, seconded by Trustee Paul File, to approve an Office 365 One Note software for the LaGrange Township Building Inspector building permits with a Roll Call Vote: 4 yes, 1 no, 0 absent, and 0 abstain motion carried at 7:16pm.

Trustee Amy Juroff made a motion, seconded by Treasurer Naomi J. Criswell, to amend the Deputy pay range from \$15-\$22 to \$17-\$25 on Resolution No. 7-2026 Appointed Officials/Miscellaneous Salary and Compensation for a Roll Call Vote: 5 yes, 0 no, 0 absent, and 0 abstain, motion carried at 7:19pm.

Trustee Amy Juroff gave an update on the Ambulance Barn and Southwestern Michigan Community Ambulance Service (SMCAS).

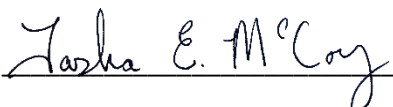
LaGrange Township Zoning Administrator Steven Allen reported to the Board of new Zoning Permits.
