Supervisor Brittany File called the meeting of the LaGrange Township Board to order at 7:00pm. Pledge of allegiance was given in unison. Roll call found Supervisor Brittany File, Trustee Amy Juroff, Trustee Paul File, Treasurer Naomi J. Criswell and Clerk Tasha E. McCoy present.

Public comment was opened at 7:01pm. Public comment closed at 7:08pm.

Supervisor Brittany File made a motion, seconded by Trustee Amy Juroff, to approve the minutes of the June 15, 2026 meeting as presented. Motion carried, 7:09pm.

The Treasurer's Report was provided to the Board.

Communications were read to the Board and Public by Supervisor Brittany File.

Trustee Paul File made a motion, seconded by Treasurer Naomi J. Criswell, to approve the Current Month Warrant Report, totaling \$200,687.54. Motion carried, 7:13pm.

Supervisor Brittany File made a motion, seconded by Clerk Tasha E. McCoy, to amend the Agenda to include "Canada Goose Resolution #14-2026" Motion carried, 7:13pm. Resolution #14-2026 was read to the Board and Public. Treasurer Naomi J. Criswell made a motion, seconded by Trustee Amy Juroff, to approve Resolution #14-2026 for a Roll Call Vote: 5 yes, 0 no, 0 absent, and 0 abstain, motion carried at 7:15pm.

The Central Cass Interlocal Fire Department (CCIFD) Fire Chief informed the Board of 54 CCIFD calls May and June 2026 and the next Fire Board meeting is scheduled in September.

Trustee Amy Juroff informed the Board of the next Ambulance meeting to be held July 23, 2026 as well as the July Board of Review scheduled for July 21, 2026 at 3:30pm. Also, there were 35 Ambulance runs in June 2026.

Trustee Paul File informed the Board of the next Planning Commission meeting to be held September 16, 2026 at 7:00pm. Trustee Paul File reported on Zoning at Cass Street.

Electrical, Mechanical, Plumbing, and Building Reports were received by the Board.

Treasurer Naomi J. Criswell made a motion, seconded by Supervisor Brittany File, to approve a Office 365 the LaGrange Township Supervisor and Trustee, motion carried at 7:25pm.

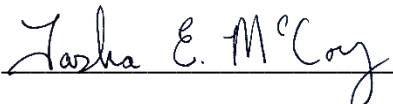
Supervisor Brittany File and Treasurer Naomi J. Criswell gave an update on Market One and Grants.
