December 15, 2025

Supervisor Brittany File called the meeting of the LaGrange Township Board to order at 7:00pm. Pledge of allegiance was given in unison. Roll call found Supervisor Brittany File, Treasurer Naomi J. Criswell, Trustee Amy Juroff, Trustee Paul File, and Clerk Tasha E. McCoy present.

Public comment was opened at 7:00pm. No Comment. Public comment closed at 7:01pm.

Supervisor Brittany File made a motion, seconded by Trustee Amy Juroff, to approve the minutes of the November 17, 2025 meeting as presented. Motion carried, 7:01pm.

Treasurer Naomi Criswell provided the Treasurer's Report. Clerk McCoy made a motion, seconded by Supervisor Brittany File, to approve Settlements #6 of the Summer 2025 Taxes. Motion carried, 7:01pm.

Communications were read to the Board by Supervisor Brittany File.

Trustee Paul File made a motion, seconded by Trustee Amy Juroff, to approve the Current Month Warrant Report, totaling \$27,817.84. Motion carried, 7:20pm.

Clerk McCoy updated the Board on the Indiana Michigan Power Light at the intersection of Park St. & Maple St. The light is going to be re-installed per an email from Indiana Michigan Power and an order number of 045254845.

The Central Cass Interlocal Fire Department (CCIFD) Fire Chief provided the Board a CCIFD Balance Sheet and a copy of the quote for a new fire truck. CCIFD Fire Chief Locke reported 13 runs since the November 17th Board meeting. CCIFD Fire Chief Locke informed the Board of a Communication Grant (matching funds Grant) received by CCIFD in the amount of \$4,900.00.

Trustee Amy Juroff updated the Board on the Central Cass Ambulance Authority (CCAA) and Southwestern Michigan Community Ambulance Service Inc. (SMCAS) that the new contract for ambulance services began December 1, 2025.
